**IT IS AGREED AS FOLLOWS:**

**1. INTERPRETATION**

In this agreement

**"Team management"** means those person or persons appointed by the NZCTA for the purpose of managing the New Zealand team participating in the event mentioned in clause 2 of this agreement.

**"Team"** means those persons who have been selected by the NZCTA to participate in the event above named with the team member.

**"Due date"** means the date by which this agreement must be delivered to the National Secretary of the NZCTA

**"Executive Officer"** means the Executive Officer of the NZCTA

**"Championship"** means the championship or championships set out in clause 2a of this agreement.

**2. TERMS OF AGREEMENT**

a. This agreement sets out the terms and conditions which you must comply with as a member of the New Zealand team competing in the.....between the \_\_\_\_\_ day of \_\_\_\_\_ and the \_\_\_\_\_ day of \_\_\_\_\_

b. I acknowledge that my selection is conditional upon me entering into this agreement and returning it to the NZCTA by 5pm on the due date time being of the essence.

c. I acknowledge this agreement will only come into effect if I am selected for the team and if I am selected will commence upon the day my selection is confirmed in writing by the Executive Officer, or team Manager and will conclude at the expiration of five working days from the closing of the Championship.

**3. IF I AM SELECTED IN CONSIDERATION OF MY SELECTION I AGREE:**

a. To observe and comply with the criteria for entry and the Rules and Regulations of the Championship, the terms of this agreement and the Constitution and Regulations of the NZCTA.

b. Whilst a member of the team to be subject to the control, management and direction of the NZCTA, through the Team management and any persons appointed by it.

c. To observe and comply with all reasonable directions given by the NZCTA, through its Team Management, and any person appointed by it.

d. To conduct myself in a proper manner (including being responsible in the use of alcohol) so as not to bring myself, the NZCTA or the Team into disrepute or censure to the absolute satisfaction of the Team Management and the NZCTA.

e. Not to make, comment, issue, authorise, offer or endorse any public criticism or statement having or designed to have a prejudicial effect on the interest of the Championships, the NZCTA, the Team or any

member of those organisations.

f. If travelling with the team (and not independently) will travel to and depart from the Championships upon the dates and in the manner determined or approved by the NZCTA through its Team Manager.

g. If living in team accommodation approved by the Team Manager (and not in independent accommodation) will abide by the rules governing residency of the team accommodation.

h. To meet all the costs of my travel to and from the Championships (including internal travel), entry fees and residing in the team accommodation as determined by the Team Manager, including accommodation, meals, laundry, phone and other incidentals, unless otherwise agreed in writing by the Team Manager.

i. To procure all necessary permits for firearm imports/exports to all countries travelling through or to, including New Zealand.

j. To meet the costs of my Travel and Health Insurance covering the period the team is overseas.

k. To conduct myself in such a manner as to obtain and maintain by best possible physical fitness and health to carry out my duties to the NZCTA and the Team to the best of my ability.

l. To advise the NZCTA:

1. should I suffer any injury or illness likely to impede my shooting performance during the term of this agreement.

2. if I am required for medical reasons to take a drug or drugs that may result in my contravention of any anti-doping regulations and/or disqualification from competition, or that may affect the teams result in any competition.

m. To only make comment to any media personnel in relation to my own preparation or performance and not to comment on the team or section as a whole.

n. To comply with the NZCTA dress codes set by the Team Manager and wear the appropriate team uniform as and when required. Any competitor who has obligations to a sponsor must declare them in the space provided on this form. Should there be any conflict of interest then NZCTA dress code requirements set by the Manager shall take precedence.

o. I am the holder of a NZ Firearms Licence No.....

### **3. DRUGS**

a. I will not use, attempt to use, have in my possession, attempt to have in my possession, traffic or attempt to traffic, any drug that is prohibited in the country of the Championship, the countries through which I may travel, or that is prohibited in New Zealand nor use any drug that may lead to me or the team being disqualified from winning the Championship.

### **4. TERMINATION OF AGREEMENT**

a. Either party may terminate this agreement on giving the other party not less than 14 days prior written notice.

5. In the event I breach any terms or conditions of this agreement I acknowledge the NZCTA or team management may in its absolute discretion:

a. immediately terminate my membership of the team, and or

b. exclude me from team competition, and or

c. take appropriate disciplinary action as specified in Section 18 (t) of the Constitution of the NZCTA. Such action may include my suspension or banning from any competition sanctioned by the NZCTA.

### **5. APPEAL RIGHTS**

Should I be subject to penalties in accordance with Section 21 (g) of the NZCTA constitution, I acknowledge am entitled to right of appeal to the NZCTA Council. Such appeal shall be forwarded to the National Secretary of the NZCTA within thirty days of notice of the disciplinary action.

**6. GOVERNING LAW**

The laws of New Zealand shall govern this Agreement and only the Courts of New Zealand shall have jurisdiction.

**7. PRIVACY ACT 1993**

I consent to the NZCTA collecting details of my performance record and personal records for use and publication as the NZCTA determines. I acknowledge my right to have access to this information. This consent is given in accordance with the Privacy Act 1993.
