### SHOOTER'S CONTRACT

Your selection as a member of the New Zealand Shooting Team is conditional upon you entering into this contract and signing and returning it to the Executive Officer at the address below by the DUE DATE advised.

This is a legally binding document and therefore you should read this document carefully so as to understand it and if necessary, seek legal advice. The undersigned would be happy to discuss any matters with you.

Shooters should retain a copy of this contract for their records and sign the other, and return it to the address below either by email or post, or send it to the team manager for this event.

#### 1. INTERPRETATION

In this contract:

**"Team management"** means those person or persons appointed by the NZCTA for the purpose of managing the New Zealand team participating in the event mentioned at the end of this contract.

**"Team"** means those persons who have been selected by the NZCTA to participate in the event.

**"Due date"** means the date by which this contract must be delivered to the Executive Officer of the NZCTA.

**"Championship"** means the event or events NZCTA is sending teams to.

#### 2. TERMS OF CONTRACT

- a. This contract sets out the terms and conditions which you must comply with as a member of the New Zealand team
- b. You acknowledge that your selection is conditional upon entering into this contract and returning it to the NZCTA by 5pm on the due date advised.
- c. You acknowledge this contract will commence upon the day your selection is confirmed in writing by the Executive Officer, or Team Manager and will conclude at the expiration of five working days from the closing of the Championship.

#### 3. I AGREE:

- a. To observe and comply with the criteria for entry and the Rules and Regulations of the Championship, the terms of this contract and the Constitution and Regulations of the NZCTA.
- b. Whilst a member of the team to be subject to the control, management and direction of the NZCTA, through the Team Management and any persons appointed by it.
- c. To observe and comply with all reasonable directions given by the NZCTA, through its Team Management, and any person appointed by it.

- d. To conduct myself in a proper manner (including being responsible in the use of alcohol) so as not to bring myself, the NZCTA or the Team into disrepute or censure to the absolute satisfaction of the Team Management and the NZCTA.
- e. Not to make, comment, issue, authorise, offer or endorse any public criticism or statement having or designed to have a prejudicial effect on the interest of the Championships, the NZCTA, the Team or any member of those organisations.
- f. If travelling with the team (and not independently) will travel to and depart from the Championships upon the dates and in the manner determined or approved by the NZCTA through its Team Manager.
- g. To meet all costs of my travel to and from the Championships (including internal travel), entry fees, accommodation, and meals.
- h. To procure all necessary permits for firearm imports/exports to all countries travelling through or to, including returning home to New Zealand.
- i. To meet the costs of my travel and health Insurance covering the period the team is overseas.
- j. To conduct myself in such a manner so as to carry out my duties to the NZCTA and the Team to the best of my ability.
- k. To advise the Team Manager and/or NZCTA:
  - 1. should I suffer any injury or illness likely to impede my shooting performance during the term of this contract.
  - 2. if I am required for medical reasons to take a drug or drugs that may result in my contravention of any anti-doping regulations and/or disqualification from competition, or that may affect the teams result in any competition.
- l. To only make comment to any media personnel in relation to my own preparation or performance and not to comment on the team or NZCTA as a whole.
- m. To comply with the NZCTA dress codes set by the Team Manager and wear the appropriate team uniform as and when required. Any competitor who has obligations to a sponsor must declare them in the space at the end of this form. Should there be any conflict of interest then NZCTA dress code requirements set by the Team Manager shall take precedence.
- n. I will not use, attempt to use, have in my possession, attempt to have in my possession, traffic or attempt to traffic, any drug that is prohibited in the country of the Championship, the countries through which I may travel, or that is prohibited in New Zealand; nor use any drug that may lead to me or the team being disqualified from winning the Championship.

## **5. TERMINATION OF CONTRACT**

- a. Either party may terminate this contract on giving the other party not less than 14 days prior written notice.
- b. In the event I breach any terms or conditions of this contract I acknowledge the NZCTA or team management may in its absolute discretion:
  - 1. immediately terminate my membership of the team, and/or
  - 2. exclude me from team competition, and/or
  - 3. withhold any team funding payment I was entitled to and/or
  - 4. take appropriate disciplinary action as specified in the Constitution of the NZCTA.

Such action may include my suspension or banning from any future competition sanctioned by the NZCTA.

## 6. APPEAL RIGHTS

Should I be subject to penalties in accordance with the NZCTA constitution, I acknowledge I am entitled to the right of appeal to the NZCTA Council. Such appeal shall be forwarded to the Executive Officer of the NZCTA within thirty days of notice of the disciplinary action.

## 7. GOVERNING LAW

The laws of New Zealand shall govern this contract and only the Courts of New Zealand shall have jurisdiction.

## 8. PRIVACY ACT 2020

I consent to the NZCTA collecting details of my performance record and personal records for use and publication as the NZCTA determines. I acknowledge my right to have access to this information. This consent is given in accordance with the Privacy Act 2020.
